

Participant Consent Form and Waiver - i-Jump (Trampoline Parks) Limited

PLEASE READ THE FOLLOWING VERY CAREFULLY BEFORE SIGNING – THIS IS AN IMPORTANT AND LEGALLY BINDING AGREEMENT.

Trampoline activities are fun but are also physically demanding and potentially dangerous. Whilst i-Jump staff will take all appropriate precautions to prevent accidents, you should be aware that injuries, both minor and major, and even death, may result from trampolining and trampoline-related activities (“the **Activities**”). The rules and conditions of use set out below are for your safety.

1. You confirm that your level of fitness is sufficient to undertake the Activities. You agree to comply with all height, weight and age restrictions in place from time to time. You do not suffer from, or have suffered from, any medical condition (including pregnancy) that might make participating in the Activities dangerous for you or others. You confirm that you are not under the influence of alcohol or drugs or are otherwise impaired in any way.
2. You confirm that you have received and understood a full safety briefing prior to starting the Activities.
3. You agree to wear the appropriate safety socks at all times and will not wear any dangerous clothing or have on your person any sharp, heavy or otherwise dangerous articles. Lockers are available for the storage of personal property.
4. You agree to comply at all times with all instructions from i-Jump staff. If you fail to comply with instructions you may be excluded from i-Jump and no refund will be given.
5. Eating and drinking whilst using the Facilities is not permitted as it could cause injury to yourself or others.
6. You will wait until the trampoline or other facility is clearly free from any other participant's use before using it yourself.
7. You agree not to attempt any tricks, manoeuvres or moves that are not comfortably within your skill levels.
8. You acknowledge that while participating in the Activities you are responsible for your own safety and the safety of others and must diligently exercise proper care at all times.
9. You acknowledge, accept and assume all risks inherent in the Activities. The Activities are physically demanding and potentially dangerous with risks that injury, paralysis or death as well as damage to your property or other participants or their property may occur.

10. You agree and acknowledge that you will be liable for your own and any other participants' injuries or damage to property if at any time you fail to follow the instructions provided.
11. You agree that neither i-Jump, its landlord, employees, owners and directors or the suppliers of the equipment used in the Activities shall be responsible for any injury loss or damage to you save in respect of liability for any personal injury or death caused by the negligence of i-Jump or that other party.
12. You confirm that you are aged 16 years or older at the date below. If you are 15 years or younger a parent or legal guardian must sign on your behalf. Participants aged 12 years and younger must only undertake the Activities when a parent, legal guardian or responsible adult over the age of 18 is present on the premises.
13. You agree that i-Jump may contact you by email and offer promotional incentives and news updates on i-Jump.
14. You agree that this waiver applies for this visit and all visits you make to i-Jump in the next 12 months from the date below.
15. i-Jump reserves the right to make changes to the services and activities advertised for any reason and without notice.
