Useful Terms and Acronyms about Safeguarding.

DSL

Designated Safeguarding Lead. A member of staff who has had advanced Safeguarding Training.

Usually a Head of Year.

### **DBS**

Disclosure and Barring Service. Used to make safe recruitment decisions.

#### **MASH**

Multi Agency Support Hub.

The NCC single point of contact to report all safeguarding concerns.

#### **TAC**

Team Around the Child.

A meeting as part of Early Help to create a plan to support a child.

#### **TAF**

Team Around the Family.

A meeting as part of Early Help to create a strategy to support a family.

#### **NSCP**

Nottinghamshire Safeguarding Children Partnership. A partnership of organisations in Notts that work to safeguard children.

Online Safety Cyber bullying is any form of bullying which takes place online through any electronic device. This could happen to anyone and at any time so we all have to be aware of it. This type of bullying can be carried out almost anywhere and at any time. Victims can feel frightened, intimidated and alone. People can be subjected to fake gossip and rumours, having videos or pictures posted about them, being called names and derogatory terms and even receive voice notes that insult them. Online bullying can also cause arguments in school and threatening behaviour. The internet and social media are great places to learn and have fun with friends. However, we still need to protect ourselves from possible risks.

## **Age Restrictions on Social Media**

Social Media is always changing and developing and this brings new risks. Do you know what your child is doing on line? Are you routinely talking to your child and checking what internet sites they are accessing? It is very important to monitor and teach your child some key internet safety rules.

- 2. Think carefully before posting pictures or videos of yourself or others. Once you have put a picture online you don't know who will share it.
- 3. Keep privacy setting as high as they can be
- Never give out your passwords.
   Don't befriend or add people you don't know.
- 5. Don't meet people you met online.
- 6. Remember not everyone is who they say they are.
- 7. Think carefully about what you say you post something. Once it is sent you can't get it back.
- 8. Respect other people's views, even if you don't agree with them.
- 9. Use parental safety app
- 10. Unsure games are age appropriate
- 11. If a website or comment makes you uncomfortable, tell an adult and leave the site. You could report it to the moderator.

## What can Parents/Carers do?

If you concerned about the risks of social media you could remove some of these risks by creating a family social media account that you all have access to. This enables you to control the privacy settings and monitor how the account is being used. You could delete your child's personal account. The rules around age restrictions are in place to protect children and should be followed. We are aware that a lot of our students have Tik Tok accounts, but the age restriction for this site is 13. It is important that you discuss safe internet use with your child.

As a school we know that students have posted pictures and videos that they later regret. When posting things online it is important that children understand that some content may offend others. Videos and pictures that are designed to upset and hurt others are not acceptable. It is our aim that Meden students are kind and respectful people at all times.
